**19/20 Approval of Minutes.** Members **RESOLVED** and the chair signed the minutes from a General Meeting of Weedon Parish Council held on 15 January 2020, as an accurate record.

**21/20 Planning. 20/00256/APP /** Paddock Field High Street Weedon Buckinghamshire HP23 4NS / Proposed stable block, manège and access road on existing paddock field along High Street. Timber post & rail fencing will be installed to enclose a manège and existing field. A permeable access road will be created to access the stable block with enough space for turning/reversing.

- Protection of endangered species

**23/20 Footways.** Members discussed a potential conversion of stile to kissing gate at Aston Abbots Road (previously John Woodfield's field). The new landowner and his tenant had agreed the stile can be replaced with a kissing gate. Members **RESOLVED** to purchase a wooden pedestrian kissing gate kit and get quotes for installation when purchased.
