## 53/21 Planning

**21/01238/APP** 18 High Street Weedon Buckinghamshire HP22 4NW / Alterations to North West Elevations

The Chair closed the meeting to allow the applicant to speak about her planning application. She said her aim was to restore the building back to the stunning house that it once was. She has applied to reduce the size of the front windows from retail to domestic and change the former 'shop' door to a window. The door to the right of the building had always been used as the house entrance/exit. She has consulted with all the immediate neighbours and no-one has objected. She also wishes to remove the former shop fascia board. There was a short question and answer session. The Chair closed the Open Forum for the Councillors to discuss the application.

Weedon Parish Council RESOLVED no objections to 21/01238/APP.
